

INTERNET PLATFORM INFORMATION TEXT

1. IDENTITY OF THE DATA OFFICER

We, as Öz-Ege Tütün Sanayi ve Ticaret Anonim Şirketi (Öz-Ege Tobacco Industry and Trade Joint Stock Company, "Öz-Ege" and/or "our Company"), display utmost sensitivity on the security and confidentiality of your personal data and personal data of private nature. With this awareness, we, as Öz-Ege, attribute a great importance to the confidentiality of the customer and accordingly to process and maintain and keep confidential all kinds of personal data belonging to our customers in the best possible way and with care. With the full understanding of this responsibility, we, with the title of data officer in the scope of the Law on Personal Data Protection (the "Law") no: 6698 and the other related legislation, process your personal data in the way described below and within the borders ordered by the legislation.

2. COLLECTION, PROCESSING AND PROCESSING PURPOSES OF PERSONAL DATA

Your personal data, even though it may vary related with the product or service or commercial activity offered by Öz-Ege, is collected verbally, in written or electronically via automatic or non-automatic methods. Your personal data of general nature and private nature can be processed as long as you use the services of our company in order that the services are presented in the best way by our company by creating and/or updating with the purposes below included, but not limited to:

Your personal data, such as the identity data, communication data, visual/audio data etc. given in the job applications to be done by means of using the form on our internet site.

Your personal data, such as the identity data, communication data etc. you would give in the job applications to be done by means of using the communication form on our internet site.

Your digital trace data and cookie data shall also be processed in case that you visit our internet site or surf in these sites.

Your personal data and personal data of private nature are processed with the purposes of:

Offering the services of our company, conducting the recruitment procedures, fulfilling the aftersales services, increasing the customer satisfaction, evaluating and responding the complaints and recommendations, being able to do statistical analyses, fulfilling the legal and regulatory requirements, procuring necessary information according to the requests and audits of the public authorities, conducting the necessary services, including research, analysis, reporting, control, audit, etc. in the scope of conducting the business processes of the company, ensuring adaptation to the rules and policies of the company.

Furthermore, your personal data, stated above, shall be able to be processed in the framework of the obligations arisen from the legal regulations such as Turkish Obligations Code, Turkish Code of Commerce, Tax legislation and the Law no: 5651 and the situations made mandatory by the other competent public authorities and the provisions of the other legislation and transferred to the physical archives and information systems belonging to our Company and kept under protection both in the digital environment and physical environment.

3. TRANSFERRING THE PERSONAL DATA

Your personal data, within the scope of the Law and other legislation and with the purposes described in the article 2 of this Information Text, depending on the reason requiring transfer and not limited with this reason:

May be transferred to the auditory and regulatory public organizations and institutions (BTK, TUIK, courts, banks, etc.), auditors, the companies providing software and hardware support services, and private persons, legally authorized, such as lawyers in the scope of the law and related regulations.

4. THE METHOD OF AND LEGAL REASON FOR COLLECTING PERSONAL DATA

Your personal data can be collected as required by the making and/or execution of the contract, with the reasons such as anticipation by the laws, legal responsibility, legitimate interest of the data officer or preservation of the right with automatic or non-automatic ways. Your personal data can be processed and transferred in the electronic environment, through our internet site, in the scope of the personal data processing conditions and purposes stated in the articles 5 and 6 of the Law, according to the basic principles anticipated in the Law, with the purposes stated in the articles 2 and 3 of this Information text.

5. YOUR RIGHTS ABOUT THE PROTECTION OF PERSONAL DATA

You have the rights of knowing whether the personal data is processed or not, if the personal data is processed, requesting information on this, knowing the purpose of processing the personal data and whether these are used according to the purpose or not, knowing the third persons to whom the personal data is transferred in or outside the country, in case that the personal data was processed wrong or insufficiently, requesting that these are corrected and requesting that the procedure done in this scope is notified to the third persons to which this data is transferred, in case that the reasons requiring processing disappear, even though they are processed according to the provisions of the Law on Processing Personal Data and the other related laws, requesting that the personal data is deleted or destroyed and requesting that the procedure done in this scope is notified to the third persons to which this data is transferred, in case that your processed data is processed exclusively by analyzing by means of automatic systems, in case of the probability that a detrimental results emerges, objecting this, in case that damages are incurred because the personal data was processed on the contrary to the law, requesting that the damages are compensated.

Our company shall conclude the application requests according to the nature of the request and within at most thirty (30) days according to the article 13 of the Law. However we'd like to state that, in case that your requests requires a cost, this cost may be asked from your by our Company as required by the mentioned article of the Law.
